

Spread the Love - Redecor Design Contest - Official Rules

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN THIS CONTEST. A PURCHASE DOES NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED.

- 1. OVERVIEW:** Spread the Love Contest (the "**Contest**") consists of a contest where eligible Entrants can enter and whereby one (1) Entrant will be named winner.
- 2. ELIGIBILITY:** Contest is open worldwide to individuals who are 18 years of age or older ("Entrant(s)"). Employees and the immediate families of Reworks Oy ("Sponsor"), and each of its respective employees, representatives, franchisees, parents, retailers, distributors, subsidiaries, affiliates, suppliers, advertising agencies, and persons living in the same household as such employees are not eligible to participate in the Contest. Contest is subject to all applicable federal, state, provincial, local laws and regulations and is void where prohibited by law. Sponsor reserves the right to verify the eligibility and all facts at any time, and Entrants agree to cooperate in any verification process/request.
- 3. CONTEST PERIOD:** The Contest begins at approximately 09:00:00 am EST and ends at approximately 11:59:59 pm EST each day starting on December 10, 2023 and ending on December 12, 2023 ("Contest Period").
- 4. HOW TO ENTER:** During the Contest Period, share your creation on your Facebook profile and Instagram, or story with the hashtag #loveredecor, tag Redecor and your ideal travel partner and tell them why you chose them
- 5.** Tell us who inspires you to design and to whom you dedicate your design. Tag Redecor using the hashtag #loveredecor in your post. Design is not required. Incomplete Entries are void. Limit of one (1) Entry per person per Contest Period. Any attempt to enter more than once by any means, including, but not limited to, use of multiple identities, email addresses, accounts, or other means may result in disqualification from this and any other promotional offerings by Sponsor. Use of any macro, bot, script or other automated means to submit entries is prohibited. No responsibility is assumed for lost, late, damaged, misdirected, illegible, incomplete, incorrect entries or other Contest submissions, all of which are void, or for errors due to computer malfunctions, software errors, transmission problems or interruptions in operations.
- 6. WINNER SELECTION / NOTIFICATION:** There will be one (1) winner selected.

Beginning on December 10, 2023, a selection panel will review all applicants, and choose one (1) winner ("Winner"), who created and shared the best design.

The judging criteria shall be:

30% Writing style

40% Emotion

30% Originality and Creativity

Entrants irrevocably agree to be bound by these Official Rules and by the decisions of the judges, which are final and binding in all respects.

7. **GRAND PRIZES:** One (1) available – One (1) Winner will receive a gift card worth USD 500, as elected by the Sponsor. No substitute prize is available. If the Winner is unavailable to receive the prize for any reason, or for no specific reason, the prize will be forfeited. Approximate Retail Value (“ARV”): USD 500.

Conditions Applicable to All Prizes: Winner will be notified via Facebook messenger. No liability is assumed for any Winner notification that is lost, intercepted or not received by a potential winner for any reason. Failure to respond to any winner notification within 48 hours may result in disqualification and selection of an alternate winner. Prize winner are solely responsible for all applicable federal, state and local taxes, and any other costs or expenses not specifically set forth herein. Any winner, as a condition to receiving any prize, may be required to sign and return an affidavit of eligibility and liability/publicity release or similar document and complete, sign, and submit to Sponsor or Administrator an IRS Form W-9 or equivalent form with the winner’s full taxpayer identification number within five (5) days of notification to winner of his/her prize eligibility. caused by a computer or mobile device related virus or otherwise resulting to any computer or mobile device from such person's participation in the Contest whether human, mechanical or electronic. Sponsor reserves the right to modify, extend, suspend, or terminate the Contest, in whole or in part, if it determines, in its sole discretion, that the Contest is technically impaired or corrupted or that fraud or technical problems, failures or malfunctions or other unintended circumstances, such as epidemic for example, have impaired the integrity, administration, security, proper play and/or feasibility of the Contest as contemplated herein. If the Contest is terminated before the end date, Sponsor will post a notice on <https://www.redecor.com/> and, to the extent possible, winners will be selected from among all eligible entries unaffected by any error that were received as of the termination date. Persons found tampering with or abusing any aspect of this Contest, or who Sponsor believes to be causing malfunction, error, disruption, or damage will be disqualified. Entries that contain errors, or are incomplete or received after the Contest Period, will not be accepted. Sponsors reserve the right to grant further Prizes, which could be governed by other rules, all of which are contingent on Sponsor's sole discretion.
